*Program Description* : Grants are made to qualified intermediary organizations that will provide financial and technical assistance to help recipients develop their capacity to undertake projects for housing, community facilities, or economic development.

The recipients are the Leslie County Fiscal Courts, Perry County Fiscal Courts and Eastern Kentucky Concentrated Employment Program, Inc.
MD	Enterprise Community Partners, Inc. *	\$250,000	To provide financial and technical assistance to one non-profit and four tribal organizations in rural reservations and pueblos in New Mexico and South Dakota. All recipients are located in StrikeForce areas.
MN	The Iniative Foundation <sup>&amp;</sup>	\$172,372	To provide training, technical assistance and financial support to 20 non- profit organizations serving low-income rural communities in central Minnesota.
MS	Hope Enterprise Corporation *	\$250,000	To provide economic development training and technical assistance to five city governments and four Hope Credit Union branches.
	North Carolina Association of Community Development Corporations *	\$100,000	To enhance the capacity of five recipients to implement community development strategies.
