Rural Development funds will be used by Samaritan Health Service to purchase and install videoconferencing technology that will expand its ability to deliver mental health care. The enhanced system will be based on direct video interactions between clinicians, patients and practitioners at 13 rural hospitals and clinics, and will also help to train the medical staff with interactive medical courses. With direct access to specialists at nearby hospitals, Samaritan can improve its response to emergencies and extend specialty coverage in its underserved rural communities. The service area includes three counties of Western Oregon, much of which are federally designated as Primary Medical Care Health Provider Shortage Areas and Medically Underserved Areas.

### **Curry Health District**

Rural Development funds will be used to purchase and implement telemedical devices, and to provide training on how to use and integrate the equipment into Curry Health District's healthcare delivery system. The District will use the new equipment to link to existing and emerging telehealth networks and tap into a wider array of specialists to treat patients and assist clinicians. The Curry Health Network serves the rural communities in and around Port Orford, Gold Beach, and Brookings, Oregon. Curry County's rural population of 22,000 is spread across 3,000 square miles, primarily along the 121-mile coastline. Patients in these remote areas currently have to travel up to 300 miles to the nearest urban center for specialist consultation and care.

USDA Rural Development funds will assist Providence Hospital in assembling a telestroke network connecting five end-user hospitals in five Eastern and Central Oregon counties to their hub hospital in Portland. Often when a stroke occurs for a patient in a rural area, practitioners are often untrained in evaluating and treating the stroke. Also, patients often have large distances to travel to get to experienced hospitals, or there is a lack of neurologists and/or inconsistent neurology support. When a stroke occurs, every second counts. Telestroke provides real-time health care, and enables stroke experts to assess, diagnose and make treatment recommendations for patients at distant locations. Medical carts will be deployed at the end-user hospitals which will allow for round the clock availability of stroke neurologists. A mobile platform robot device with human-like mobility will be controlled by the neurologist at a distance to perform examinations. The same teleconferencing system that is used for telestroke and consultations can also be used for training primary providers, nursing, and EMS staff. Providence will match grant funds with \$127,000 of local funding.

USDA Rural Development funds will enable the Airport District to establish a distance learning network across six counties in Southwestern Oregon to teach fire suppression science, search and rescue, and first responder training to rural fire departments and port districts. The Airport District will be equipped with a video conferencing package, including document scanner, smart board, and computer system. The participating 11 fire protection districts and three (shallow-draft) port districts will be supplied with video conferencing media carts endowed with laptops. The Airport District is able to leverage its teaching and content

resources and draw from its local organizations, such as the North Bend Municipal Fire Service, Southwestern Oregon Community College (which offers certificate programs in fire science and emergency medical services), Ocean Air Aviation (which provides medical evacuation services), and the U.S. Coast Guard (well-known for over-water rescue). Coos County Airport District will match grant funds with \$135,000 of local funding.

#### North Central Educational Service District

USDA Rural Development funds will be used by Region XV to expand an existing system, as two schools will be receiving video conferencing equipment and brought-in as new video endpoints. Region XV has a 2,500-mile service territory, larger than nine U.S. states. Region XV offices, as system hub, will receive a multi-point bridge, content server, and other control equipment allowing them to link the video network among 30 schools. Participating locations all contribute to provide classes to each other, sharing teachers, courses, and learning. The new curriculum presented will offset classes that are either not available, or are not robust or advanced enough for academic achievement. Those courses would include math and science, health, technology literacy and foreign languages for K-12 students, professional development and mentoring for teachers, and continuing education and workforce development for adult learners. North Central will match grant funds with \$156,455 of local funding.

These telemedical stations will be placed at the public elementary and high school where they can serve the students, their parents, and other residents. ADAPT will incorporate its own backup satellite uplink units and generators to insure medical coverage during emergency conditions such as power outages and cellular blind spots

Among the services to be delivered are remote diagnosis, urgent and preventive care, chronic disease management, and telepsychology

western Oregon. The area served is a rural area, with the exception of the hub equipment located in Eugene, OR. The clinics and hospitals will be connected by DS-3 or wireless spread spectrum to the hub location at the Sacred Heart Medical Center in Eugene. Rather than storing radiology scans on film and transporting them to Eugene, the local facilities will now be able to send 128-bit encrypted data files which can be translated and read on-site at the major medical facility. This is expected to save hours of diagnostic and travel time, as well as compensate for the lack of specialized radiology staff in those rural locations.

The predominant goal of this project is to provide over 150,000 residents with greater access to health care resources (educational and medical) at eleven (11) end-user locations served by the Samaritan Hospital and clinics through teleconferencing capabilities. The project involves a combination and coordination of health services provider sites, education sites and public access sites. Specifically, the project provides for three types of applications which are:

(1) the expansion of administrative conferencing and meetings to reduce travel, costs, and increase participation for health care professionals; (2) continuing education for health care providers, including physicians, nurses and paraprofessionals; and, (3) medical consultations with for rural patients which will assist with overcoming the shortage of physicians particularly medical specialists in the project service area.

Some of the services provided through this project include: adult education courses; English as a second language courses; college level courses from local universities; career and personal counseling; individual and group tutoring and short term training for local businesses. The service area of this project is comprised of 4,442 square miles of rugged, mountainous country presenting significant transportation challenges. The economy of this once thriving region experienced a dramatic shift with the decline of the timber industry. The two counties in this service area have the second and seventh highest drop out rates in the state. The combination of these two factors has led to a workforce that is under trained and ill equipped to handle the challenges of the future. The distance learning opportunities that this project will provide is part of a comprehensive plan to "retool" this area to meet those challenges - educational advancement, job growth and improvement to the local economy.

Grant funds will be used by North Lincoln Hospital Foundation to establish a secure medical network (LC2 Regional Medical Network) via broadband connectivity among and between Samaritan North Lincoln Hospital, Good Samaritan Hospital, Pacific City Health Clinic, Lincoln City Medical Center, Coastal Health Practitioners, Confederated Tribes of the Siletz Community Health Clinic, The City of Lincoln City, Lincoln County Health and Human Services and Oregon Heath Sciences University. Development of this project resulted from a severe shortage of nurses, a limited number of specialized physicians, and geographic and demographic barriers. This network will be the first telemedicine program of its kind in the county. Physicians will be able to see and consult with some of the best specialists to provide better quality care to the rural residents, expert diagnostic consultations will be instantly available when emergency care is needed, and transport of patients will be reduced. In addition to the telemedicine services that will be provided by this network, training will be offered to area citizens for health care careers.

Specifically, the project establishes a broadband infrastructure for secure, high speed connectivity among seven health care providers in Jackson and Joseph Counties. The system connects physicians to specialists for consultations and eliminates patients' long distance travel for diagnostic assessments. The project also enhances the delivery of continuing education offerings to health care professionals and current medical and research information to both patients and health care professionals. It enables patients to partner with their physician in making health decisions and treatment courses.

FLN is proposing to utilize a central hub, located at NCESD's administrative office in Condon, connected via a wireless telecommunication system to 6 classroom facilities, located in 6 school districts. Through a LAN, these end user sites will allow linkages to 8 additional classroom facilities and 4 mobile instruction centers. This system will also enhance medical services by linking 4 local medical clinics in the 3,767 square mile region to each other and to Mid-Columbia Medical Center.

Klamath Community Development Corporation (KCDC) is a non-profit organization, which with the partnership of Klamath Community College, will establish a distance learning network utilizing RUS grant funds to serve Klamath and Lake Counties. Klamath and Lake Counties are in a rural area crossed by mountain ranges and connected by two lane roads which are under snow and ice conditions during six to nine months a year. Commuting, either by students or teachers would be dangerous if not impossible. The telecenter which will house the output for the system will be located in Klamath Falls and will serve communities ranging in distance from 30 miles to over 100 miles distant. The educational opportunities provided with the help of the RUS grant funds will enable the community to provide a quality work force to attract and retain new business and industry to replace the declining timber industry in this region.
