El Departamento de Agricultura, Desarrollo Rural Business-Cooperative Service está considerando una solicitud de garantía de préstamo de conformidad con la Sección 9003 del Acta de Alimentos, Conservación y Energía de 2008 recibida de BBVA Compass Bank, para TerraFuels, LLC para construir y operar un bio-refinería de basura municipal post-clasificada que se encuentra en Alvin, el Condado de Galveston, Texas (Latitud 29° 25' 8" N Longitud 95° 11' 30" W). La propuesta incluye la construcción de la bio-refinería y su infraestructura relacionada que se encuentra en aproximadamente 10 acres de terreno situado al sur y una instalación de reciclaje y disposición en las planicies costera. La bio-refinería propone el uso de basura municipal post-clasificada para la producción de la deserción en la gasolina verde que contribuyan a satisfacer las necesidades de los requisitos federales estándar de combustibles renovables.



### Preliminary Notice of Possible Impact on Important Resources

TerraFuels  
Galveston County, Texas

The USDA, Rural Business-Cooperative Service is considering an application for loan guarantee pursuant to Section 9003 of the Food, Conservation, and Energy Act of 2008 received from BBVA Compass Bank, for TerraFuels, LLC to construct and operate a Post Sorted Municipal Solid Waste (PSMSW) Biorefinery to be located in Alvin, Galveston County, Texas (Latitude 29° 25' 8" N Longitude 95° 11' 30" W). The proposal would include the construction of the biorefinery and its related infrastructure to be located on approximately 10 acres of land located directly south and adjacent to Waste Management's Coastal Plains Recycle and Disposal Facility. The biorefinery proposes the use PSMSW for production of drop-in green gasoline that will contribute to meeting the requirements of the federal Renewable Fuel Standard requirements.

If implemented, the proposal may directly or indirectly affect up to approximately 1 acre of potentially jurisdictional wetlands and/or waters of the U.S. and up to 10 acres of prime farmland. If impacts to wetlands or waterways are unavoidable a permit will be submitted to the U.S. Army Corps of Engineers and compensatory mitigation will be required. The purpose of this notice is to inform interested parties and the public, of possible impacts to wetland, waters of the U.S., or prime farmland and to request comments concerning the proposal.
