Currently, the city's library is housed in a building constructed in 1920 - one of the oldest structures in the city. The building is not disabled-compliant under the Americans with Disabilities Act (ADA). The floor in the main room is sinking due to deteriorating floor joints, to access the front or rear entries, users must navigate stairs and there is not enough space inside the building nor on the adjacent exterior sidewalks to create a ramp. There is limited space for activities in the children's area, computer stations are in the center of the main room, which allows patrons limited privacy, and there is very little storage space available for general office and cleaning supplies. Similar limitations affect the existing Chamber of Commerce office, which consists of an 88 square-foot room shared by two employees. This project will provide access to new and improved cultural resources and address existing limitations with accessibility, energy, and construction.
