By law, the definition of “eligible rural area” differs for each USDA Rural Development program, and the statutory rural area eligibility criteria can be complex. Additionally, states can include exceptions for specific communities based on regional circumstances. Please use Rural Development’s Eligibility Tool (available at this link: [eligibility.sc.egov.usda.gov](http://eligibility.sc.egov.usda.gov)) to help determine if your project is in an eligible rural area and you are otherwise eligible to apply.

<b>Rural Community Development Initiative Grants (RCDI)</b>	RCDI grants support housing, community facilities, and community and economic development projects in rural areas through technical assistance and training. Fund uses include training subgrantees to conduct home-ownership and minority business entrepreneur education, strategic plan development, accessing alternative funding sources, board training, and creating training tools such as videos, workbooks and reference guides. Grants range from \$50,000 - \$250,000. <b>Rural Cooperative Development Grants</b>	RCDG grants improve economic conditions in rural areas by helping people start, expand or improve rural cooperatives and other mutually-owned businesses through Cooperative Development Centers. Examples of fund usage include undertaking feasibility studies, providing leadership and operational improvement training, and facilitating strategic planning. <b>Rural Economic Development Loans (REDL) and Grants (REDG)</b>	<p>REDLGs offer zero-interest loans to qualified local utilities. In turn, the utilities pass the loans through to local businesses for use in projects that create and keep employment in rural areas. In the REDG program, local utilities use grants to establish revolving loan funds to support projects that create or save rural jobs. <b>Community Facilities (CF) Direct Loan and Grant Program and Loan Guarantees</b>	<p>CF funds can help offset the cost of constructing, expanding, or improving public service buildings. Examples include fire and first responder stations, health care clinics, hospitals, child care centers, assisted living and rehabilitation centers, schools, and libraries, among others. Financing also can cover the cost of land acquisition. A typical grant award ranges between 15 – 75 percent of eligible project costs.
