## Assistance for Rural Homeowners and Rental Tenants

Home Repair Loan & Grant Program	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA provides loans and grants to help eligible homeowners make repairs to their homes.</li> <li>• Grants are limited to individuals age 62 or older. Rural Housing Direct Loan Program	Disaster Assistance

<p>USDA home loan borrowers who may have lost their job or had their hours reduced due to a disaster may receive assistance on their loan payment. Options may include payment reduction, moratorium, or workout agreement.</p> <p>Through the Rural Housing Direct Loan Program, USDA can offer subsequent loans to current borrowers for essential repairs to their homes.</p>	<p>USDA Customer Service Center: (800) 414-1226. Multi-Family Housing	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA finances affordable rental housing in rural areas for low-income families, farmworkers, the elderly and people with disabilities.</li> <li>• USDA provides rental assistance to low-income tenants of USDA-financed properties to prevent rent payments from exceeding 30% of the tenant's income.</li> </ul>	<ul style="list-style-type: none"> <li>• Anyone impacted by a natural disaster can receive a Letter of Priority Entitlement (LOPE) for USDA-financed properties</li> <li>• USDA can waive deposit, age restrictions and lease requirements</li> <li>• USDA can allow zero income applicants to live in apartments, offer available rental assistance, use imputed income from assets</li> <li>• Contact USDA: Deborah Boyd, <a href="mailto:deborah.boyd2@ca.usda.gov">deborah.boyd2@ca.usda.gov</a> or 530-792-5817</li> </ul>

## Assistance for Rural Communities

Community Facilities Loan & Grant Program	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA provides loans and a limited amount of grant funding for the construction, renovation, or purchase and installation of equipment for essential community facilities for public use in rural areas.</li> <li>• Eligible projects include fire and police facilities, community centers, hospitals, schools, city vehicles, food banks, daycare centers, and more.</li> <li>• Eligible applicants include most state and local government entities, nonprofit organizations and federally recognized Tribes.</li> <li>• Projects must be located in rural areas and towns of up to 20,000 in population.</li> <li>• Grants range from \$20,000 - \$30,000. Long-term fixed-rate loans. Water & Waste Disposal Loan & Grant Program	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA provides loans and a limited amount of grant funding for the construction, renovation, and purchase and installation of equipment for water and waste disposal systems in rural communities.</li> <li>• Eligible applicants include most state and local government entities, nonprofit corporations and federally recognized Tribes.</li> <li>• Grants may be provided in conjunction with loans to help reduce user rates. ## Assistance for Rural Businesses

Business & Industry Loan Guarantee Program	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA guarantees loans made by commercial lenders to rural businesses. USDA may guarantee up to 80% of loans of \$200,000 to \$5 million and up to 70% on loans up to \$10 million.</li> <li>• Rates and terms are negotiated between the business and the lender.</li> <li>• USDA charges an initial guarantee fee equal to 3% of the guaranteed amount plus an annual renewal fee equal to .50% of the guaranteed amount</li> <li>• A bank, credit union, insurance company or other lender may request a USDA guarantee on a loan made to a proprietorship, partnership, corporation, LLC, cooperative, trust, nonprofit, tribe, or public body for projects in unincorporated areas and cities with populations of less than 50,000.</li> <li>• Funds may be used for equipment, real estate, working capital and refinancing.</li> <li>• Eligible businesses include wineries.</li> <li>• Web: <a href="https://www.rd.usda.gov/programs-services/business-industry-loan-guarantees/ca">https://www.rd.usda.gov/programs-services/business-industry-loan-guarantees/ca</a></li> </ul>	<ul style="list-style-type: none"> <li>• USDA can help businesses recover from the damages caused by a natural disaster by guaranteeing their business loans with eligible lenders.</li> <li>• Contact USDA: Karen Rich, <a href="mailto:karen.rich@ca.usda.gov">karen.rich@ca.usda.gov</a> or 530-792-5825</li> </ul>

Revolving Loan Funds	Disaster Assistance
<ul style="list-style-type: none"> <li>• USDA provides seed capital to revolving loan funds operated by qualified nonprofits and public bodies. Known as intermediaries, these lenders finance small and emerging businesses and community development projects in rural areas.
