Paying off an existing debt with these funds will keep the payments <u>affordable.</u>

The ISO rating is required to keep the residents' insurance premiums affordable. The new truck will provide better protection for <u>the city of Elkmont.</u>

There will also be a <u>community room, kitchenette, accessible bathrooms and a small office.</u>

More than seventy percent of the city 7,473 housing units were built in 1970 and earlier posing a higher risk of residential fires. It is anticipated that all city fire services will be consolidated into this new facility resulting in faster response times to calls for emergency service.
