Page two of this guide is a sample poster. It is only an example so owners or managers can adapt it to their project. All advertisements/marketing must include the Fair Housing Logo "Equal Housing Opportunity" AND the picture of the house. All advertisements should contain a statement that units are available for persons with disabilities even if the project does not have a handicap unit(s) or if the handicap unit(s) is occupied. If the project has a handicap unit, all advertising/marketing must contain the handicap logo. All advertisement/marketing (including web sites) for USDA loan/grant recipients (borrowers) must include the USDA nondiscrimination statement.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, religion, sex, gender identity (including gender expression), sexual orientation, disability, age, marital status, family/parental status, income derived from a public assistance program, political beliefs, or reprisal or retaliation for prior civil rights activity, in any program or activity conducted or funded by USDA (not all bases apply to all programs).
