

The following Florida cities/towns/places and contiguous densely populated areas will become ineligible:

Alachua County

- Gainesville – Already ineligible. All areas annexed by the city will become ineligible.

Bay County

- Panama City Beach and contiguous Laguna Beach
- Lynn Haven and contiguous areas west to North Bay, east to North Bay, and southeast to US 23
- Callaway and contiguous areas north to power easement and east to Callaway Bayou

Brevard County

- Port St. John and contiguous area north and west to I-95
- Titusville - Already ineligible. All areas annexed by the city will become ineligible.

Charlotte County

- Punta Gorda and contiguous developments west of US 41

Collier County

- Naples and contiguous areas north to county line, east to I-75 and Collier Blvd, south to Marco Island, and west to the coast
- Golden Gate city limits
- Marco Island city limits

Duval County

- Atlantic Beach - Already ineligible. All areas annexed by the city will become ineligible.
- Jacksonville Beach - Already ineligible. All areas annexed by the city will become ineligible.

Escambia County

- Gonzalez CDP and contiguous areas west to power easement and southeast to county line

Flagler County

- Palm Coast - Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

Hillsborough County

- Fish Hawk CDP limits
- Sun City Center CDP limits
- Plant City - Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

Indian River County

- Sebastian city limits and contiguous areas north and west to Sebastian River, and east to the coast

Lake County

- Lady Lake town limits north of CR 466 and areas surrounded by town limits
- Eustis city limits south of CR 44 and areas surrounded by city limits
- Tavares city limits north of Milwaukee Avenue and east of Dead River to Mount Dora city limits, and areas surrounded by city limits
- Mount Dora city limits west of Britt Road and US 441 and areas surrounded by city limits
- Clermont city limits

Lee County

- San Carlos Park CDP limits and east to electric power easement pass Florida Gulf Coast University
- Estero village limits – A portion is already ineligible. All areas annexed by the city will become ineligible.

Manatee County

- Palmetto city limits and contiguous areas west to the coast, east to I-75 and northeast to 39th Street East
- Bradenton city – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

Marion County

- Ocala city – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.
- The Villages – Already ineligible. Contiguous areas east to SE 130th Avenue and north to CR 42 will become ineligible

Martin County

- Jensen Beach CDP limits and contiguous areas west to county line and east to the coast
- Stuart city limits, areas surrounded by ineligible areas and contiguous areas east to the coast, south to Atlantic Ridge Preserve State Park (CR 76 A) , and west to St. Lucie Canal
- Palm City CDP limits and contiguous area east to Stuart city limits
- Hobe Sound CDP limits and contiguous area north to Stuart city limits

Miami Dade – the entire county will become ineligible

Okaloosa County

- Niceville city limits and contiguous areas east to FL 293, southeast to county line, west to county line, southwest to currently ineligible areas pass county line and south to the coast
- Destin city limits and contiguous areas north to the bay and Miramar Beach to the east

Orange County

- Apopka city – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.
- Ocoee – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

- Winter Garden - Population has increased to over 35,000. City limits and areas surrounded by city limits will become ineligible.
- Lake Butler - A portion is already ineligible. Contiguous areas surrounded by ineligible areas will become ineligible.
- Horizon West - A portion is already ineligible. Contiguous area west to FL 429 will become ineligible

Osceola

- St. Cloud – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.
- Kissimmee – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

Palm Beach

- Belle Glade city - Already ineligible. All areas annexed by the city will become ineligible.

Pasco County

- Land O' Lakes CDP limits south of Tower Road will become ineligible
- Trinity CDP - A portion is already ineligible. Contiguous area to east boundary of Trinity Memorial Gardens will also become ineligible.

Polk County

- Lakeland – Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.
- Winter Haven - Already ineligible. All areas annexed by the city and areas surrounded by ineligible areas will become ineligible.

Santa Rosa County:

- Midway CDP limits and south to the coast
- Navarre CDP limits and contiguous area east to ineligible area in Okaloosa County

Sarasota County

- North Port – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible. Contiguous Warm Mineral Springs will also become ineligible.

Seminole County

- Oviedo – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.
- Sanford – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.
- Winter Springs city limits

St. Johns County

- Palm Valley CDP limits and east to the coast
- Fruit Cove CDP limits

St. Lucie County

- Lakewood Park CDP limits and east to the coast
- Port St. Lucie – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.
- Fort Pierce – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.

Sumter County

- The Villages - Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible. Contiguous area north to county line will also become ineligible.

Volusia County

- Daytona Beach – Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.
- Port Orange – Already ineligible. All areas annexed, contiguous area west to Spruce Creek, and areas surrounded by ineligible areas will become ineligible.
- Deland - Already ineligible. Contiguous areas and areas surrounded by ineligible areas will become ineligible.
- Edgewater city - Already ineligible. Contiguous areas and areas surrounded by ineligible areas will become ineligible.
- Orange City limits and all areas surrounded by city limits
- Deltona - Already ineligible. All areas annexed and areas surrounded by ineligible areas will become ineligible.
