Rural Funding Forum at SUNY Morrisville

Morrisville, NY — On Tuesday, March 26th, 2019 representatives from the United States Department of Agriculture (USDA) Rural Development agency and the U.S. Small Business Administration (SBA) gathered at the State University of New York (SUNY): Morrisville to present on a number of business related programs and resources that are available to the rural small business community in NY.

This was the second in a series of forums that are taking place throughout NY this fiscal year which are highlighting the Memorandum of Understanding (MOU) between the USDA and the SBA. Richard Mayfield, NY State Director for USDA Rural Development and Steve Bulger, SBA Regional Administrator shared program information as well as listened to the needs of the more than two dozen stakeholders who attended.
