AK	Copper River-Ahtna Inter-Tribal Resource Conservation District	\$287,552	To provide technical assistance for Alaska Native entrepreneurs for a biomass feedstock harvest project, which will create 25 jobs.
AZ	Yavapai-Apache Nation	\$57,000	To conduct a feasibility study/market plan to determine the best location for a vineyard and winery business.
AZ	San Carlos Apache Tribe Relending Enterprise	\$500,000	To provide technical assistance and business loans for Tribe members.
ID	Nez Perce Tribe	\$146,236	To buy and equip a greenhouse to produce and sell native plants and seeds. The project will create 3.5 jobs.
ID	Nez Perce Tribe	\$121,995	To buy biodiesel manufacturing equipment to produce and sell canolabased biodiesel.
MN	Dakota Futures, Inc.	\$200,000	To provide loans for small businesses in the Lower Sioux Indian Community. The project will create 14 jobs.
