When the original fire station was constructed, they averaged 60 fire and rescue calls per year. In 2018, they had 488 calls. The township population has grown as well as the demand for the services of the fire department. They provide firefighting, response to medical emergencies, vehicle accidents, water and ice rescues and other free community services. They also provide mutual aid to surrounding townships. The new facility will be over 11,000 square feet and will have four drive-through apparatus bays, a work space with an emergency wash area, office space, locker rooms, a dispatch room, multipurpose space with a warming kitchen, mezzanine storage and mechanical space and a general circulation area. The property will be three acres and will be landscaped with fencing to provide noise barriers to adjacent properties.
