USDA Rural Health Liaison

- Rural Health Liaison appointed in March 2022
- 2018 Farm Bill created USDA Rural Health Liaison to
 - Coordinate across USDA, with Dept of Health and Human Services (HHS), and other partners to promote rural health
 - Share information and data related to USDA programs with customers and rural health information with USDA programs and partners
- Rural Health Fellow established in July 2023
 - 1-year Extension until July 2025
 - New recruitment funded to begin Summer 2025

Who are we?

- **Rural Development** functions as the **World Bank** for rural America
- With almost 5,000 staff and over **\$250 Billion in assets**, Rural Development ranks as the **14th largest bank in the U.S.,*** and one of the largest lenders to rural America
- RD provides **direct loans, guaranteed loans, grants, and technical assistance** support to rural communities to fund the development of **utilities** like electric, telecommunications, and water resources; the purchase and construction of **homes**; the development of **community** facilities; and the financing for **small business**.

Background

- **Foundations for Evidence-Based Policymaking Act** (Evidence Act) places significant responsibilities on Federal agencies with respect to data sharing. The intent is to make government data more accessible both to the public and among Federal agencies.
- **USDA Rural Development's (RD) Data Governance Board** explored the possibilities of expanding public access to RD data.
- This involved identifying open data sites and platforms, developing and implementing open data standards, exploring new open data opportunities in RD, and identifying partnership opportunities to increase data sharing.

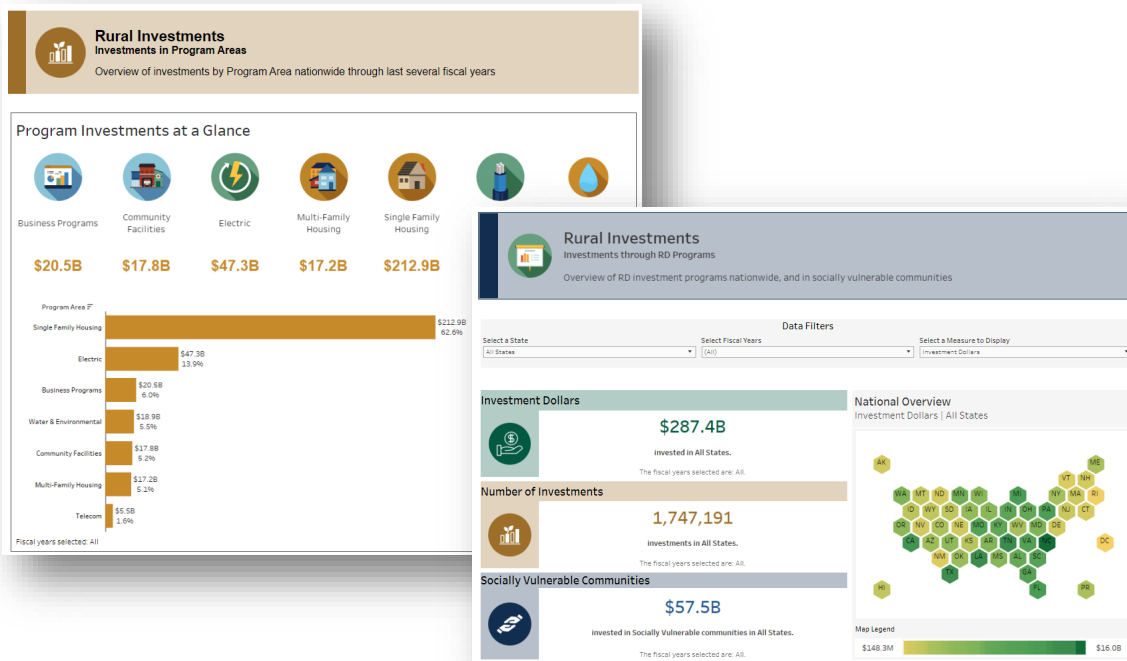

About the Data

- Over 12 years of RD investment data from FY 2012 through FY: (to date) that have been publicly announced
- The information presented on the dashboards represents approximately 99% of the total dollar amount of RD investment
- Weekly update of all publicly announced obligations
- Not a financial report of record
- Data subject to change based on project status (e.g., cancellati funding amount adjustments, etc.)
- Single Family Housing Program aggregated at county level to comply with privacy requirements
- State view only for Telecom and Electric program investments other programs have County and Congressional District views
- Option to download project level data for ALL programs except Single Family Housing (due to privacy issues)

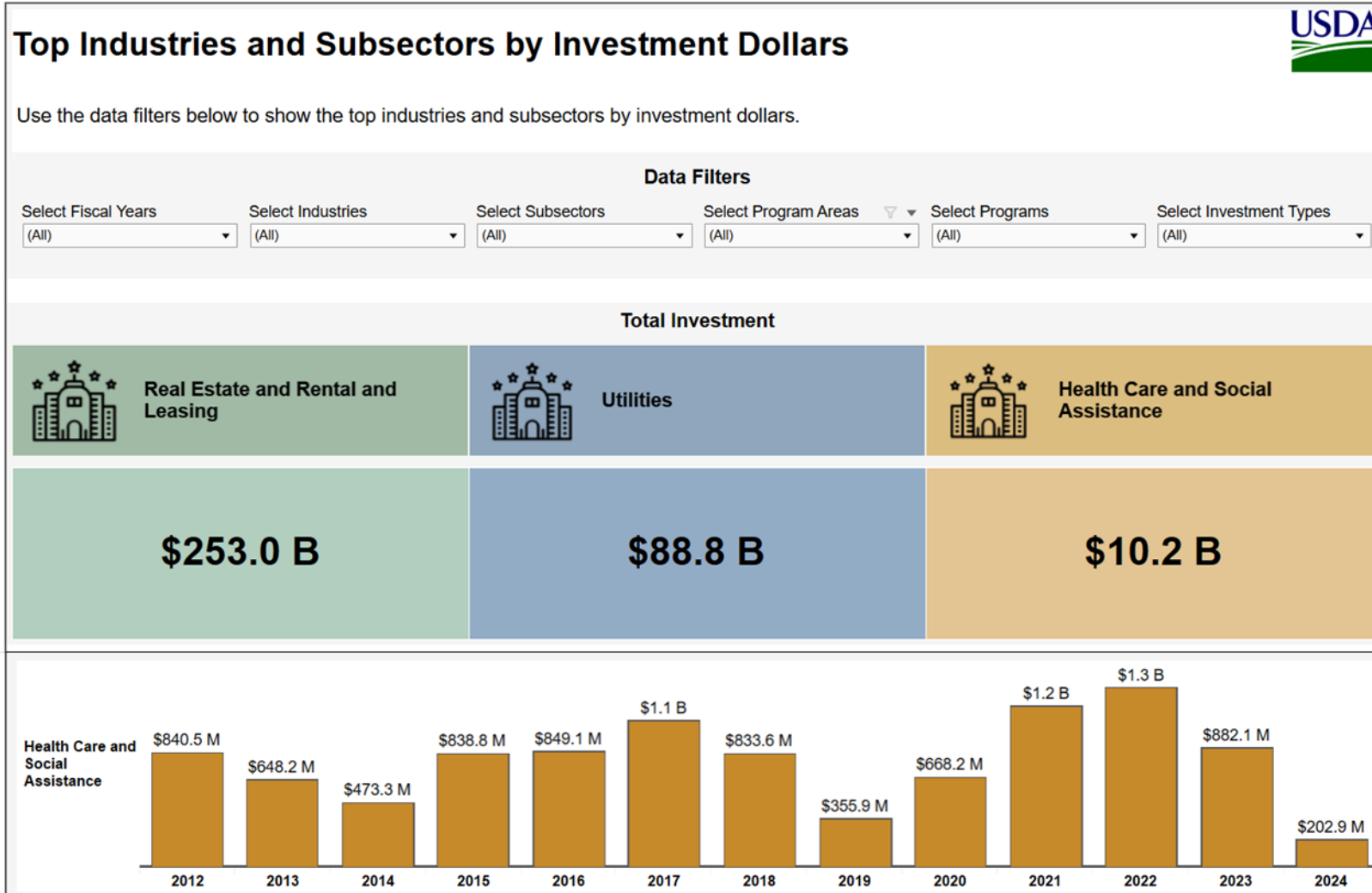
