# Rural Utilities Service Notice of Funding Opportunity for Rural Decentralized Water

# **Systems Program for Fiscal Year 2023**

# **Rural Decentralized Water Systems Program**

**SUMMARY:** The Rural Utilities Service (RUS or Agency), a Rural Development (RD) mission area of the United States Department of Agriculture (USDA), announces acceptance of applications under the Rural Decentralized Water Systems (DWS) program for Fiscal Year (FY) 2023. These grant funds will be made to qualified types of applicants to create a revolving fund to finance the costs of household water well systems and individually owned decentralized wastewater systems. Projects should consider energy efficiency, resiliency, and water reuse technologies. This program will have up to \$8,984,405.47 available for FY 2023. All applicants are responsible for any expenses incurred in developing their application.

#### A. **Program Description**

1. *Purpose of the Program.* Access to safe and reliable water and wastewater systems is vital to both human health and economic development. Due to a variety of factors, it is not always feasible to have public water or wastewater services run to each residence. In those instances, individual well water and septic systems may be the most technical and financially feasible means of providing access to safe and reliable water and wastewater services. The Rural Decentralized Water Systems (DWS) program was established to help individuals with low to moderate incomes finance the costs of household water well systems and individually owned decentralized wastewater systems that they own or will own.

Through the DWS Program, private non-profit organizations will receive grant funds to establish lending programs that will provide water well and septic system loans and sub-grants to individuals. Considerations should be given to technology that supports energy efficiency, resiliency, and water reuse. The individuals, as loan or grant recipients, may use the funds to construct, refurbish, and service their household well or decentralized wastewater systems up to the point of entry to the residence. In certain circumstances where ground well water contamination is documented, funding may be used to complete work beyond the point of entry to the residence. A loan may not exceed \$15,000 and will have a term up to 20 years at a one percent annual interest rate. Where necessary, up to 25 percent of the awarded funds may be used as grant.

2. *Statutory and Regulatory Authority*. The DWS program is authorized under Section 306E of the Consolidated Farm and Rural Development Act (CONACT), 7 USC 1926e and implemented by 7 CFR part 1776 Rural Decentralized Water Systems.

3. *Definitions*. The definitions appliable to this notice are published at 7 CFR part 1776.3.

4. *Application of Awards*. The Agency will review, evaluate and score applications received in response to this notice based on the provisions found in 7 CFR 1776.9 and as indicated in this notice. Awards under the DWS will be made on a competitive basis using specific selection criteria contained in 7 CFR 1776.9 and this notice. The Agency advises all interested parties that the applicant bears the full burden in preparing and submitting an application in response to this notice regardless of whether or not the applicant receives funding pursuant to the DWS program in FY 2023.

## **B.** Federal Award Information

Type of Awards: Grants

Fiscal Year Funds: FY 2023

*Available Funds:* Funding for FY 2023 is up to \$8,984,405.47. RUS may at its discretion, increase the total level of funding available in this funding round from any available source provided the awards meet the requirements of the statute which made the funding available to the Agency.

Award Amounts: No minimum or maximum award amount.

Anticipated Award Date: September 30, 2023

Performance Period: October 1, 2023 to September 30, 2024

*Renewal or Supplemental Awards:* Prior DWS grants cannot be renewed. Existing DWS awardees can submit applications for new projects which will be evaluated as new applications. Grant applications must be submitted during the application window.

*Type of Assistance Instrument*: Grant Agreement

### **C.** Eligibility Information

1. Eligible Applicants. Eligible applicants must meet the eligibility requirements of 7 CFR

1776.5.

2. *Cost Sharing or Matching*. Applicants must be able to comply with the applicant contribution requirements outlined in 7 CFR 1776.9(b)(3).

*3. Other.* Applicants must be able to meet the intent outlined in 7 CFR 1776.1 and 1776.12. Also, applicants will need to comply with 7 CFR 1776.13 and 7 CFR Part 1776, Subpart C. Non-tribal applicants proposing to serve households on tribal lands must submit a tribal resolution of support with their application from the Tribe, or Tribes, that have jurisdiction over those lands.

A loan or subgrant recipient must be an eligible individual as defined in 7 CFR 1776.3 and 1776.14. In determining eligibility, income does not include income earned or received by dependent children under 18 years old or other benefits that are excluded by Federal law. RUS publishes a list of income exclusions in 7 CFR 3550.54(b). Also, the Department of Housing and Urban Development published a list of income exclusions in the <u>Federal Register</u> on May 20, 2014, at 79 FR 28938 (see "Federally Mandated Exclusions").

## **D.** Application and Submission Information

1. *Address to Request Application Package*. Application information is available at <u>www.grants.gov</u>. The FY 2023 DWS Application Guide, copies of necessary forms and samples, and the DWS Program regulation are available at <u>https://www.rd.usda.gov/programs-services/water-environmental-programs/rural-decentralized-water-systems-grant-program;</u>

2. *Content and Form of Application Submission.* To be considered for funding, applicants must be an eligible entity and must submit a complete application by the deadline date. Applicants should consult the cost principles and general administrative requirements for grants pertaining to their organizational type to prepare the budget and complete other parts of the application.

Applications should be prepared in accordance with 7 CFR part 1776 and this Notice. The Agency developed an application guide for this program that provides specific, detailed instructions for each item comprising a complete application. The Agency emphasizes the importance of including every item and strongly encourages applicants to follow the instructions carefully, using the examples and illustrations in the application guide. Applicants should ensure they are using the most updated version of the application guide before submitting an application. Any updates to the application guide will be posted at

3. System for Award Management and Unique Entity Identifier.

(a) At the time of application, each applicant must have an active registration in theSystem for Award Management (SAM) before submitting its application in accordance with 2CFR part 25. In order to register in SAM, entities will be required to obtain a Unique EntityIdentifier (UEI). Instructions for obtaining the UEI are available at

(b) Each applicant must maintain an active SAM registration, with current, accurate and complete information, at all times during which it has an active Federal award or an application under consideration by a Federal awarding agency.

(c) Each applicant must ensure they complete the Financial Assistance General Certifications and Representations in SAM.

(d) Applicants must provide a valid UEI in its application, unless determined exempt under 2 CFR 25.110.

(e) The Agency will not make an award until the applicant has complied with all SAM requirements including providing the UEI. If an applicant has not fully complied with the requirements by the time the Agency is ready to make an award, the Agency may determine that the applicant is not qualified to receive a Federal award and use that determination as a basis for making a Federal award to another applicant.

#### 3. Submission Dates and Times.

(a) *Application Technical Assistance*. Prior to official submission of applications, applicants may request technical assistance or other application guidance from the Agency, so long as such requests are made prior to the application deadline. RUS contact information can be found in FOR FURTHER INFORMATION CONTACT section of this notice.

(b) *Application Deadline Date*. Completed electronic applications must be submitted through <u>www.grants.gov</u> by 11:59 p.m., Eastern Time (ET) on June 10, 2023. DWS program will start accepting applications on May 10, 2023. Late or incomplete applications will not be accepted. If the submission deadline falls on Saturday, Sunday, or a federal holiday, the application is due the next business day.

The Agency will not solicit or consider extra scoring or eligibility information that is submitted after the application deadline. RUS also reserves the right to ask applicants for clarifying information and additional verification of assertions in the application. 5. *Intergovernmental Review*. Executive Order (EO) 12372, "Intergovernmental Review of

Federal Programs," does not apply to this program.

*Funding Restrictions*. Applications must be for eligible uses outlined in 7 CFR 1776.12.
 Administrative expenses that may be funded are outlined in 7 CFR 1776.13.

7. Other Submission Requirements.

(a) Beginning with this Application Cycle, the Agency will only accept Applications

electronically. Applications must be submitted electronically through <u>https://www.Grants.gov</u>. RUS may request original signatures on electronically submitted documents later. All electronic documents must be submitted in Excel, Word, or PDF format. If system errors or technical difficulties occur, use the customer support resources available at the Grants.gov website.

(b) Applicants must be registered with Grants.gov before a grant application can be submitted. If you have not used Grants.gov before, you will need to register in SAM. SAM registers your organization and stores your organizational information, which allows Grants.gov to use it to verify your identity. The registration processes may take up to 10 business days to complete. Follow the instructions at Grants.gov for registering and submitting an electronic application.

## **E.** Application Review Information

1. *Criteria*. All eligible and complete applications will be evaluated and competitively scored based on the scoring criteria and weights contained in 7 CFR 1776.9 and this notice. Failure to address any of the application criteria by the application deadline will result in the application being determined ineligible, and the application will not be considered for funding.

In order to be considered for points awarded at the Administrator's discretion pursuant to 7 CFR 1776.9(b)(7), the applicant's work plan must include a separate section titled, "Administrative Points." Applications may be awarded up to a total of 10 points for the following three priorities:

 Assisting rural communities recover economically through more and better market opportunities and through improved infrastructure. Proposals where the project is located in or serving one of the top 10% of counties or county equivalents based upon county risk

score in the United States. Information on this priority may be found at: https://www.rd.usda.gov/priority-points.

- 2. Ensuring all rural residents have equitable access to Rural Development (RD) programs and benefits from RD funded projects. Direct technical assistance to a project located in or serving a community with a score 0.75 or above on the Centers for Disease Control and Prevention Social Vulnerability Index. Information on this priority may be found at: https://www.rd.usda.gov/priority-points.
- 3. Reducing climate pollution and increasing resilience to the impacts of climate change through economic support to rural communities. Direct technical assistance to a project addressing climate impacts shown as either quantitative or qualitative. Additional information on this priority may be found at: https://www.rd.usda.gov/priority-points.
  - Quantitative: Project is located in or serving coal, oil and gas, and power plant communities whose economic well-being ranks in the most distressed tier of the Distressed Communities Index.
  - Qualitative: Demonstrating how proposed climate-impact projects improve the livelihoods of community residents and meet pollution mitigation or clean energy goals.

2. *Review Selection Process*. Within 30 days of receiving an application, RUS will provide the applicant written acknowledgement of receipt. The following actions will be taken:

(a) Incomplete or ineligible applications as of the deadline for submission will not be considered. If an application is determined to be incomplete or ineligible, the applicant will be notified in writing and the application will be returned.

(b) Complete, eligible applications will be evaluated competitively by a review team, composed of at least three RUS employees selected from the Water and Environmental Programs. They will make overall recommendations based on criteria provided in 7 CFR 1776.9 and this Notice. RUS reserves the right to request additional information once an application is determined to be complete to minimize the risk of duplication of other federal efforts. The Agency reserves the right to offer the applicant less than the grant funding requested. Lowscoring projects may not be awarded funding at RUS's discretion, even if funding remains available.

(c) Regardless of the score an application receives, if RUS determines that the project is technically infeasible, RUS will notify the applicant, in writing, and the application will be returned with no further action.

## F. Federal Award Administration Information

#### 1. Federal Award Notices.

(*a*) *Award Outcomes*. There are four possible outcomes following the submission of an application under the DWS program. RUS reserves the right to make no grant award if all applications are ineligible, incomplete, and/or do not meet the established program objectives and priorities. RUS may determine that the application is:

- *i.* Eligible and selected for funding,
- *ii.* Eligible but offered less funds than requested,
- iii. Eligible but not selected for funding due to ranking of all applications, or
- iv. Ineligible for the grant.

(*b*) *Award Notices*. Applicants selected for funding will be sent an award letter, accompanied by a grant agreement, which outlines the terms and conditions of the award, and

other applicable documents. Pursuant to the grant agreement, grant funds may be released over the course of the period of performance in reimbursement for the completion of eligible, approved activities which do not duplicate similar federal efforts or tasks. The grant agreement may also include reporting and pre-approval requirements consistent with 7 CFR part 1776 and this NOFO which if not met, may result in a delay in reimbursement, disallowance of expense, or a suspension of the grant.

The successful applicants will be required to execute documents appropriate to the project before funding will be advanced. Award documents specify the term of each award.

*(c) Payments and Reimbursements.* Pursuant to the grant agreement, grant funds will be released over the course of the grant period in reimbursement for the performance of eligible, approved activities, which do not duplicate similar federal efforts or tasks. Funding requests may be submitted for allowable costs up to monthly and must include the appropriate supporting documentation. The grant agreement will also include reporting and outline actions containing pre-approval requirements consistent with 7 CFR part 1776 and 2 CFR part 200 which if not met, may result in a delay in reimbursement, disallowance of expense, or a suspension of the grant.

*(d) Scope of Work.* The approved scope of work will be attached to the executed grant agreement. The grantee is responsible for ensuring that all contractual, legal, and program requirements are met prior to starting work. Any change in the scope of the project, budget adjustments of more than ten (10) percent of the total budget, or any other significant change in the project must be reported to and approved prior to the change by the approval official by written amendment to the grant agreement. Any change not approved may be cause for termination of the grant.

 Administrative and National Policy Requirements. Applications should be prepared in conformance with departmental and other applicable regulations including 2 CFR parts 180, 182, 200, 400 and 421, and any successor regulations.

3. *Reporting.* Performance reporting, including applicable forms, narratives, and other documentation, are to be completed and submitted in accordance with the provisions of 7 CFR part 1776, 2 CFR part 170, and 2 CFR part 200, as well as the Grant Agreement. Further, all grantees must submit an audit or financial information covering the defined period of performance as outlined in 2 CFR part 200.

## H. Other Information

1. *Paperwork Reduction Act.* In accordance with the Paperwork Reduction Act of 1995 (44 U.S.C. chapter 35), the information collection requirements associated with the programs, as covered in this notice, have been approved by the Office of Management and Budget (OMB) under OMB Control Number 0572-0139.

2. *National Environmental Policy Act.* All recipients under this notice are subject to the requirements of 7 CFR part 1970. However, awards for technical assistance and training under this notice are classified as a Categorical Exclusion according to 7 CFR 1970.53(b), and usually do not require any additional documentation. The multi-tier nature of this program may require compliance via 7 CFR 1970.55 which applies to multi-tier actions or relending actions. RUS will review each grant application to determine its compliance with 7 CFR part 1970. The applicant may be asked to provide additional information or documentation to assist RUS with this determination or enter into a multi-tier action environmental compliance agreement. The multi-

tier action environmental compliance agreement will detail the recipient's responsibilities in meeting the Agency's Environmental Policies and Procedures. The multi-tier action environmental compliance agreement acknowledges that further "tiered" environmental review is required and coordinated by the recipient prior to approving subrecipient applications for relending purposes.

3. *Federal Funding Accountability and Transparency Act*. All applicants, in accordance with 2 CFR part 25, must be registered in SAM and have a UEI number as stated in Section D.3 of this notice. All recipients of Federal financial assistance are required to report information about first-tier sub-awards and executive total compensation in accordance with 2 CFR part 170.

4. *Civil Rights Act.* All grants made under this notice are subject to Title VI of the Civil Rights Act of 1964 as required by the USDA (7 CFR Part 15 Subpart A -- Nondiscrimination in Federally-Assisted Programs of the Department of Agriculture - Effectuation of Title VI of the Civil Rights Act of 1964) and Section 504 of the Rehabilitation Act of 1973, Title VIII of the Civil Rights Act of 1968, Title IX, Executive Order 13166 (Limited English Proficiency), Executive Order 11246, and the Equal Credit Opportunity Act of 1974.
