We have reviewed the information provided in your correspondence dated May 15, 2023, concerning the proposed solar plant locations in Brownsville, Donna, Harlingen, and Raymondville, Texas. This review is part of the National Environmental Policy Act (NEPA) evaluation for United States Department of Agriculture- Rural Utility Service (USDA-RUS). We have evaluated the proposed sites as required by the Farmland Protection Policy Act (FPPA).

The proposed sites may contain Prime Farmland or Farmland of Statewide Importance, but due to sites 1A, 1B, and 1C being in or adjacent to city limit boundaries, they are exempt. The location of those 3 sites is determined to be "land committed to urban development" and is not subject to FPPA regulations. In addition to that, the installation of solar panels is not considered a permanent conversion of farmland. Therefore, the proposed project areas (1A, 1B, 1C, and 1D) are exempt from provisions of FPPA and no further consideration for protection is necessary. We urge the use of accepted erosion control methods during construction to protect and preserve soil and water resources.
