SUMMARY: Notice is hereby given that the Rural Utilities Service (RUS), as required by the National Environmental Policy Act, is issuing an environmental assessment (EA) in connection with possible impacts related to a project proposed by Arkansas Electric Cooperative Corporation (AECC), of Little Rock, Arkansas. The proposal is for the building of a new electric generating facility in Morris County, Texas. Arkansas Electric Cooperative Corporation has submitted an application to the RUS for funding of the proposal.

SUPPLEMENTARY INFORMATION: The Naples Power Plant will consist of two simple-cycle natural gas turbines with a combined nominal capacity of up to 900 Megawatts (MW). The project site will have approximately 40 acres of disturbance and is approximately one mile northwest of the City of Naples, Texas. It will include power plant infrastructure, including auxiliary equipment, switchyard, buildings, roads, and 500-foot lateral gas pipeline. The project will connect to adjacent existing utility infrastructure, including a natural gas line and electric transmission line.

Burns and McDonnell, an environmental consultant, prepared an environmental assessment for RUS that describes the project, assesses the proposed project's environmental impacts, and summarizes as applicable any mitigation measures used to minimize environmental effects. RUS has conducted an independent evaluation of the environmental assessment and believes that it accurately assesses the impacts of the proposed project. No significant impacts are expected as a result of the construction of the project.

All comments must be provided electronically with no hard copy comments being accepted at this time.
