SFH GUARANTEED LOAN PROGRAM TECHNICAL HANDBOOK. The following updates were made to HB-1-3555, Chapter 11 to permit a PITI

ratio up to 29%, revise guidance pertaining to the availability of ratio waivers, provide clarification on the treatment of debts, and make minor grammatical and formatting edits.

Paragraph 11.2 - The Ratios

- Updated the PITI ratio guidelines to reflect 29%.
- Clarified if an applicant pays off a debt to qualify, the lender must document the source of funds used.
- Clarified that to exclude a debt paid by another party, that party must be legally obligated to pay the debt.
- Clarified the Agency's guidelines on contingent liabilities.

Paragraph 11.3 Debt Ratio Waivers and Compensating Factors

Updated to clarify that ratio waivers are permissible if the requirements cited are met.
