NOTICE OF CHANGES TO ELIGIBLE AREA MAPS FOR USDA RURAL DEVELOPMENT HOUSING PROGRAMS

USDA Rural Development has completed its 2020 decennial United States census review for all areas under its jurisdiction to identify areas that no longer qualify as rural for USDA Rural Housing programs. Based on the review of the areas within the state of Texas using 2020 US census data, and rural area guidance located in Handbook HB-1-3550, Chapter 5, the rural eligibility designation has changed for the following areas:

Areas whose rural eligibility designations is changing from ineligible to <u>eligible</u> (these areas now qualify as rural for USDA Housing Programs):

- 1) Aransas Pass, Aransas County The entire City of Aransas Pass is determined to be eligible based on its population of less than 10,000
- 2) Aransas Pass, Nueces County The entire City of Aransas Pass is determined to be eligible based on its population of less than 10,000

- 10) Kingsville, Kleberg, All areas outside the city of Kingsville to be eligible based on population

- 12) Midland, Midland County, areas outside the city limits of Midland Areas to the east of Midland were determine to be eligible based on population and rural in character.
- 13) Midway South, Hildalgo County The portion of the City of Midway South that is to the east of Midway Road will now be considered an eligible area.
- 14) Mountain City, Hays County The entire City of Mountain City is determined to be eligible based on its population of less than 10,000
- 15) Oyster Creek, Brazoria County The city of Oyster Creek is determined to be eligible based on population of less than 10,000.

- 16) Palm Valley, Cameron County The entire City of Palm Valley is determined to be eligible based on its population of less than 10,000
- 17) Palmhurst, Hildalgo County The entire community of Palmhurst is eligible due to its population and rural in character review.
- 18) Port Aransas, Aransas County The entire City of Port Aransas is determined to be eligible based on its population of less than 10,000
- 19) Port Aransas, Nueces County The entire City of Port Aransas is determined to be eligible based on its population of less than 10,000
- 20) Quintana, Brazoria County The city of Quintana is determined to be eligible based on population of less than 10,000.
- 21) Reid Hope King, Cameron County The entire City of Reid Hope King is determined to be eligible based on its population of less than 10,000
- 22) Richwood, Brazoria County The City of Richwood is determined to be eligible based on its population of less than 10,000
- 23) Robstown, Nueces County The entire city of Nueces County is determined eligible based on a rural in character review.
- 24) South Point, Cameron County The entire City of South Point is determined to be eligible based on its population of less than 10,000
