They will deploy MPPEP - Phase 2 funds to purchase land and construct and equip a new facility 2.5 miles from their current location. This will allow them to nearly double their processing capacity while serving 17 new producers and hiring 28 new full-time positions.

With support from MPPEP - Phase 2, they will construct a new USDA-inspected facility designed to increase the region's processing capacity and fill the gap in the lack of available USDA-inspected services. Stan's expects to serve 50 new producers and will be hiring 20 new full-time positions.

Aligned with Hawaii's state goals and Food Self Sufficiency Strategy, Kamuela meat Co. will increase the availability of locally raised, USDA-inspected cattle, many of which are currently shipped to the continental U.S. for processing. Kamuela Meat Co. has already received reservations from 13 producers totaling more than 6500 head of cattle and expects to create 17 new jobs because of this project.

Support from MPPEP - Phase 2 will allow Sustainable Meats to expand their processing capacity and will diversify the value-added products they create including jerkies, sausages, and ready-to-eat items. They anticipate doubling both their staff and number of producers they serve to 18 and 88, respectively, because of this project.

The southeast Idaho facility will provide both USDA-inspected and organic processing services and will focus on both beef and sheep. Support from MPPEP - Phase 2 will facilitate the construction and equipping of the new facility and is expected to create 80 new full-time jobs. The facility will process 100 head of beef and 500 head of sheep per day.

With support from MPPEP - Phase 2, they will expand their slaughter and value-added processing capacity at two locations: in Pennville, they will obtain inspection under the Cooperative Interstate Shipment program, and in Redkey they will expand their further processing capacity under USDA inspection. Damian's will offer fee-for-service processing and will also purchase animals from local producers through competitive and transparent pricing. MPPEP - Phase 2 funds will help support a range of start-up costs, including land acquisition, facility construction, equipment purchasing, and initial operations. Currently, there are no federally inspected processing facilities within a 60-mile radius of Washtenaw County. This project will create 12 new jobs.

The plant will be LEED certified and will supply beef to both domestic and international wholesalers, retailers, pet food companies, and food manufacturers. The operation of the new facility is expected to create 1,363 full-time jobs with annual salary ranges significantly higher than the county average.

They specialize in selling their products direct to consumers through their own retail outlet, as well as working with local restaurants and stores. With support from USDA, DeMaria's Hemlock Hill Farm will construct a new, automated poultry processing facility, creating six new jobs and doubling the number of poultry producers they serve.
