RD Resources for tenants after a disaster:

Letter of Priority Entitlement (LOPE letter), is available for current USDA RD multifamily tenants displaced by natural disaster. A LOPE allows the household to apply for housing in properties financed by USDA Rural Development or the U.S. Department of Housing and Urban Development (HUD). Tenants with LOPEs may receive priority placement in vacant units and may be move to the top of the waitlist for RD-financed multifamily properties. A LOPE is good at USDA and HUD properties anywhere in the United States or its territories.
