

For the purpose of filing a Public Notice Response, respondents must first determine whether they are already providing broadband service to any of the geographic areas included in any of the recently published Public Notice Filings. Broadband Service means fixed, terrestrial service as defined in the latest federal register notice for the respective financial assistance program under which the Proposed Funded Service Area (PFSA) was submitted for consideration. Mobile and satellite services will not be considered in making the determination of whether or not broadband service already exists in a PFSA.

Respondents are required to fill out the PNF ID, Project ID, and Service Provider Information section of the form before certifying and submitting this form to USDA. Respondents are also required to submit an ESRI zipped shapefile (Shapefile) of the area(s) where the respondent already provides broadband service within the PFSA as part of the response. A Shapefile of the PFSA(s) included in each PNF are available for download to assist respondents with their spatial response. The respondent's Shapefile can include more than one non-contiguous polygon; however, the Shapefile must include an accompanying .prj file in which the coordinate system of the data is defined, and each polygon must be closed and non-overlapping. Make sure the polygon(s) included in the Shapefile are located within the bounds of the PFSA.
