This allows for linen and medication to be stocked at night, through the corridor, so that staff won't have to interrupt the residents' sleep. Each household will have its own living, dining, kitchen, activity, and nursing areas. This project will address the needs of elderly residents in Fairmont and surrounding communities.

A 16 Bed Crisis Residential Unit (CRU) will also be incorporated within the Treatment Building to provide Substance Abuse Detox Services, Crisis Services, and Hospitalization Step-Down Services.
