#### Are you a USDA home loan borrower who is having difficulty paying your mortgage because of a natural disaster?

USDA home loan borrowers who have lost their job or had their hours reduced due to a natural disaster may be eligible to receive assistance on their loan payment.

Options available include:

- · Payment reduction
- A temporary suspension of payments (up to 180 days)
- A mortgage restructuring agreement
- · Payment assistance

## Are you a displaced homeowner or rental tenant?

• Displaced survivors in a federallydesignated disaster area can use a valid FEMA number to receive priority placement at any USDAfinanced apartment.

- Existing rental tenants in USDAfinanced apartments at the time of the disaster can ask USDA for a Letter of Priority Entitlement (LOPE) for priority placement.
- USDA can authorize its apartment property owners to waive age restrictions, as well as income, deposit or lease requirements.

## Has your business been affected by a natural disaster?

 USDA can help businesses recover from a natural disaster by guaranteeing their business loans through eligible lenders. Funds can be used for equipment, real estate, working capital, and refinancing.  USDA-funded revolving loan funds can provide financing to help eligible businesses recover from a natural disaster. USDA can put rural businesses and nonprofits in contact with intermediary lenders to discuss eligibility and availability of funds.

#### Special emergency assistance

USDA can offer special emergency assistance in designated disaster areas when funding for such assistance is allocated by Congress.
