Improvements will enable the town to supply potable water to customers, will increase system efficiency and avoid seeking additional water sources, conserve water, and provide reliable service.

The current system is more than 40 years old and is deemed unfeasible to rehabilitate. The Arizona Department of Environmental Quality placed an Administrative Order on the water system, deeming the water non-drinkable due to high Arsenic levels dating back to 2011.

The facility will offer primary care, women's OBGYN clinic, pediatric medicine, imaging, x-ray, MRI, and ultrasound, behavioral health, laboratory, and pharmacy services, nutrition classes, patient outreach program, administrative functions, call center, and patient care coordination.
