## USDA RD State Director Waring, NH Congressman Pappas Host Entrepreneurship Panel to Benefit Regional Small Business Owners

Virtual Dialogue with Area Businesses to Focus on Funding Support, Pandemic Navigation and Workforce Development

**CONWAY, N.H., March 9, 2022** – Today, <u>USDA Rural Development (RD)</u> State Director Sarah Waring and New Hampshire Congressman Chris Pappas will co-host a virtual panel to discuss the achievements, challenges and outlook of small businesses in the Granite State. To kick off <u>National Entrepreneurship Week</u> during the third week in February, RD released its <u>Entrepreneurship Resource Guide</u>, providing insights, success stories and tools for smallbusiness owners to secure funding through various federal sources and non-profit agencies. The panel will include five area small businesses from New Hampshire's 1<sup>st</sup> District that have received USDA funding in recent years.

"We are thrilled to join Congressman Pappas and these innovative entrepreneurs to discuss the small-business landscape in our region," said Sarah Waring, State Director of USDA Rural Development in New Hampshire and Vermont. "We need to know how folks are sustaining, expanding and evolving their operations in a very challenging climate. Entrepreneurs invited to participate are Chef Danny Rassi - Fire by Wicked Fresh in North Conway; John Moulton - <u>Moulton Farm</u> in Meredith; Daryl Dawson - The Kellerhaus in Laconia; Kendra Veno - Veno's Specialty Food & Meats in Conway; and Jack Clarke - Clarke Farm in Epping.

The dialogue will cover workforce development, adapting to the pandemic, and funding sources for clean energy and general business development, among other topics. RD Business Programs under discussion will include the <u>Rural Energy for America Program (REAP)</u>, <u>Rural Business</u> <u>Development Grants (RBDG)</u>, <u>Intermediary Relending Program (IRP)</u>, <u>Business & Industry</u> <u>Loan Guarantees (B&I)</u>, <u>Rural Microentrepreneur Assistance Program (RMAP)</u>, and <u>Value</u> <u>Added Producer Grants (VAPG)</u>.
