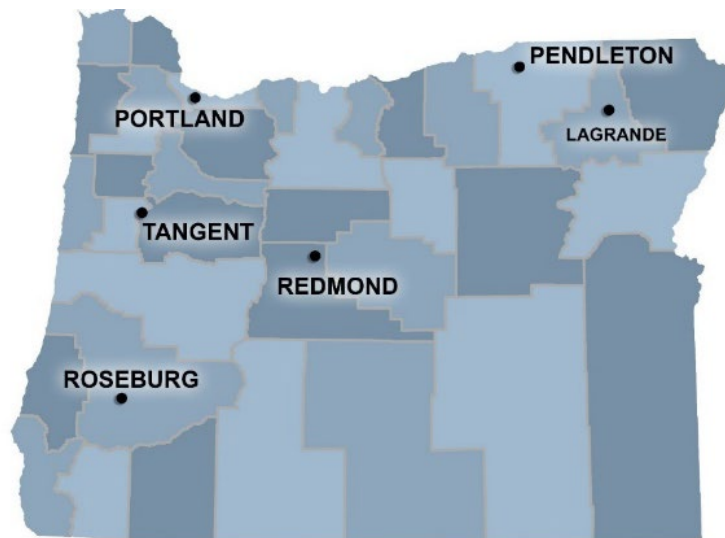

To File an Employment Complaint

To File a Program Complaint

You may also write a letter containing all of the information requested in the form. Persons with Disabilities
