Handbook is partially revised. The specific
revisions are outlined below.

### Chapter 12:

This Chapter is revised to streamline and/or clarify program requirements as follows:

- Paragraph 12.2 A, and 12.7, B, to remove the restriction on 504 funding be utilized to construct a new deck, driveways, and landscaping.
- Paragraph 12.3, updated to direct staff to provide the standardized application package.
- Paragraph12.4 B, to remove minimum trade line requirement.
- Paragraph 12.4.C, to lower the assets consideration from assets that can be converted in  $90\ \mathrm{days}$  to  $60\ \mathrm{days}$ .
- Paragraph 12.4 E, to allow grant eligible applicants to use grant funds first and foremost; and then consider loan repayment/funds as needed.
