- § 4280.48(c), revised the Instruction language to replace the 45 days to 60 days for State Office to prepare legal documents. The majority of the Instruction language for § 4280.48(d) was deleted by Program and the remainder of the instruction language was merged with § 4280.48(c) language and modified.
- § 4280.48(e) is renumbered to § 4280.48(d). To modified the Instruction language to clarify how to process Form RD 1940-1 and included language to clarify the date of execution by the State Office approving official.
- § 4280.48(f) and (g) are renumbered to § 4280.48(e) and (f).

- § 4280.55(e), removed the third sentence and in the forth sentence revised the word "those" to "any".
- § 4280.55(f), revised the word "will" in this section to "may".
